## United Way supports programming that improves the mental health of Racine County residents.

In 2021, therapists from BeLEAF Survivors' Sexual Assault Services (SAS) program served 71 clients through 1,001 therapy sessions. SAS staff and volunteers also answered 424 calls on the 24/7/365 helpline to provide crisis intervention to survivors.



**83%** of the more than 5,200 program participants reported improved mental health, leading to increased life satisfaction.



**95%** of the more than 4,800 program participants reduced or avoided risky behaviors, which improved their overall safety.

## Children and families thrive when they have the educational resources they need to succeed.

John XXIII Educational Center helps hundreds of students finish high school, pursue higher education and support their communities every year. The results are life changing. "One student continued her education at St. Mary's University to obtain her master's degree and eventually became the associate director of its First Generation Initiative." — Br. **91%** of program participants earned their high school credentials, increasing their job readiness.



**88%** of parents increased engagement with their children, strengthening their parent-child relationship.

**91%** of program participants demonstrated sound financial management, allowing them to make progress towards their financial goals.

**78%** of program participants secured employment and became more financially stable.



## United Way supports programming that fulfills the basic needs of Racine County residents.

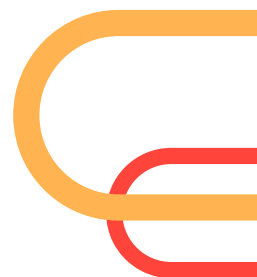
